DISTRIBUTORSHIP AGREEMENT

For Agarbatti Products

This Distributorship Agreement ("Agreement") is entered into on this

by and between:

BYABSHAR GHAR ENTERPRISE PRIVATE LIMITED, a company incorporated under the Companies Act, 2013 (18 of 2013), having its registered office at Ganrapota, Bongaon, North 24 Parganas, West Bengal, 743251, hereinafter referred to as the "Company" (which expression shall, unless repugnant to the context or meaning thereof, include its successors and assigns),

AND

Mr. / Mrs. / M/S _____,

residing at/with office at _____

hereinafter referred to as the "Distributor" (which expression shall, unless repugnant to the context or meaning thereof, include its legal heirs, representatives, and assigns).

1. Appointment

The Company hereby appoints the Distributor as its non-exclusive distributor for the sale and promotion of its Agarbatti products ("Products") within the territory of _____, and the Distributor hereby accepts such appointment.

2. Term

This Agreement shall remain in force for a period of 3 Years from the Effective Date, unless terminated earlier in accordance with the provisions herein.

3. Duties of the Distributor

The Distributor shall:

1. Actively promote, market, and sell the Products in the Territory;
2. Maintain adequate inventory;
3. Refrain from engaging in any deceptive, unethical or illegal business practices;
4. Not sell products that compete with the Company's Agarbatti line without prior written approval.
5. Sharing details of each retail shop within the company.
6. The distributor will never be able to sell products beyond the rate set by the company, if he does so, he will be fined Rs. 10,000/- (Rupees Ten Thousand) based on proof.

4. Pricing and Payment

The Distributor shall purchase the Products from the Company at prices specified by the Company from time to time and make payments as per the agreed terms.

5. Non-Compete Clause

In consideration of the Company entrusting the Distributor with its product distribution:

5.1 If the Distributor voluntarily ceases or is terminated from this distributorship for any reason, he/she/they shall not, directly or indirectly, engage in any business related to Agarbatti or incense stick manufacturing, distribution, or sales, whether individually, as a partner, proprietor, employee, consultant, or in any other capacity, for a period of five (5) years from the date of termination of this Agreement.

5.2 In the event of a breach of Clause 5.1, the Distributor agrees to pay a fine of ₹5,00,000 (Rupees Five Lakhs only) to the Company as liquidated damages and acknowledges that the Company shall be entitled to initiate appropriate legal proceedings, including but not limited to injunctions, for enforcement of this clause.

6. Termination

This Agreement may be terminated by either party with 60 days written notice, or immediately in case of breach of material terms.

7. Governing Law & Jurisdiction

This Agreement shall be governed by the laws of India. Any disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts located in West Bengal

8. Miscellaneous

This Agreement constitutes the entire agreement between the parties.

Any modification must be made in writing and signed by both parties.
